

DO I NEED VISA TO TRAVEL TO BRAZIL?

- 1) Based on the duration and the purpose of your trip, check whether you need a Visitor Visa (VIVIS) or a Temporary Visa (VITEM);
- 2) Based on your nationality (passport you hold), confirm if a visa is required ('Yes') or if you benefit from visa waiver ('No');
- 3) If you need to obtain a visa, follow the instructions present on our website.

VISITOR VISA (VIVIS): aimed at those travelling to Brazil **for maximum stays of up to 90 days**, without the intention to establish residence, for the purpose of engaging in the following activities:

- Tourism and transit;
- Business (e.g. holding meetings, participating in corporate fairs and events, seeking commercial opportunities, signing contracts);
- Non-corporate events (e.g. conferences, seminars, congresses, workshops, cultural meetings / fairs / events);
- Auditing or consultancy;
- Artistic or sports activities;
- Study, supervised academic internship, academic extension programmes, research or scientific cooperation;
- Journalistic coverage, news reporting or filming;
- Volunteer services;
- Health treatment;
- Adoption;
- Work as vessel or aircraft crew members, maritime workers;
- Family reunion (on the grounds of marriage celebrated by power of attorney);
- Other exceptional circumstances.

TEMPORARY VISAS (VITEM): length of stay varies according to the type of VITEM, nationality, supporting documentation, and authorisations (if applicable).
